Conversion Privilege	A member whose spouse ceases to be insured may ask the insurer to issue a policy of individual life insurance on the spouse's life without being required to submit evidence of insurability. A written application and first premium must be submitted to the insurer within 31 days after the member's spouse ceases to be insured. The individual policy must not be less than the minimum amount for which the insurer issues a policy and not more than the amount that was applicable to the spouse at the time the spouse ceased to be insured.
